## ORDER

In exercise of the powers conferred by section 126A of the Goa Cooperative Societies Act, 2001(Goa Act 36 of 2001), the Government of Goa hereby exempt the Cooperative Societies from the provisions to the extent specified below.

- (i) Under section 72(2) of the said Act, meeting as stated therein shall be held on or before **28**<sup>th</sup> **day of February**, **2021**.
- (ii) Under section 74(4) of the said Act, the accounts as stated therein shall caused to be audited on or before **28**<sup>th</sup> **day of February**, **2021**.
- (iii) Under Section 81 of the said Act, returns shall be filed on or before 28<sup>th</sup> day of February, 2021.

This order shall come into force with immediate effect and shall remain in force till 28<sup>th</sup> day of February, 2021.
