O R D E R

Whereas Section 91D of the Goa Cooperative Societies Act, 2001(Goa Act no. 36 of 2001) {hereafter referred to as 'said Act' or 'Act'} empowers the Registrar to issue a special Order and empower any Officer of a Federal Institution or Chief Executive of the Society to exercise powers of a Sales and recovery Officer under the Act for effecting recovery of debts and to attach and sell the property of defaulters or to execute any decree by attachment and sale of property and execution of all recovery orders of decree holder.

And whereas vide resolution no. 04 dated 12/03/2023 adopted by Board of Directors (BoD) of the Panchasheela Urban Co-Operative Credit Society Ltd. (reg. no. RES-(a)-34/NZ/GOA dated 30/04/1999), Near KTC Bus Stand, Assonora, Bardez, Goa {hereafter referred to as 'said Society' or 'Society'} it is requested to authorize the recovery officer of their Society to act as Sales and recovery officer under the Act.


And whereas vide letter read at no. 3 above, the Unit Incharge of said society has recommended the proposal stating that said Society has abided by the statutory compliances as required under the Act for period ending 31/03/2022.

Now, therefore, in exercise of the powers conferred under Section 91D of the Goa Cooperative Societies Act, 2001(Goa Act no. 36 of 2001), I, the undersigned Registrar of Cooperative Societies do hereby authorize and empower **Shri Nandesh M. Patil, Recovery Officer** of said Society to act as **Sale cum Recovery Officer** as provided under sub-section (1) of Section 91D of the Goa Coop. Societies Act, 2001, in relation to the recovery of debts and to attach and sell the property of defaulters or to execute any decree by attachment and sale of property and execution of all recovery orders of decree holder viz. **The Panchasheela Urban Co-Operative Credit Society Ltd.(reg. no. RES-(a)-34/NZ/GOA dated 30/04/1999), Near KTC Bus Stand, Assonora, Bardez, Goa.**

This appointment is subject to the following terms and conditions.

1. The Officer empowered with the powers of Sales Cum Recovery Officer shall work under the general guidance, superintendence and control of the Asstt. Registrar of Coop. Societies(Arbitration/Execution, North Goa District), Ponda-Goa and also under the supervision of Unit Incharge (ARCS or CO) of said Society at the Zonal Office where Society is registered;
2. He shall follow all the procedures as laid down under the Goa Cooperative Societies Act, 2001 and the Goa Coop. Societies Rules 2003 and comply with all other provisions of other Acts/Rules as may be applicable from time to time and shall abide by the Bye-laws of the said society while executing the Decrees;
3. The Board of Directors of the said Society shall be fully responsible along with the said **Recovery Cum Sale Officer** for any acts/omissions in contravention of the Act, Rules and Bye-laws;
4. The Board of Directors shall review the performance of the **Recovery Cum Sale Officer** every month and ensure compliance;
5. This Order shall remain in force for one year from **13/06/2023 to 12/06/2024** and the same can be withdrawn at any stage without assigning any reasons thereof.
