**ORDER**

**Whereas**, Adv. Dilip S Gaonkar , having office at A,306, 3<sup>rd</sup> floor Pereira plaza opp. Hospicio Hospital, Margao- Goa, was appointed as Registrar's Nominee under section 86(1) of the Goa Cooperative Societies Act, 2001 read with Rule 116(1) of the Goa Cooperative Societies Rules, 2003 vide Order read at Sr. No.1 above.

And whereas, the Secretary of the Suvarnlaxmi Sahakari Patapeddhi Maryadit Margao vide their letters read at Sr 3 & 5 has requested to appoint Adv. Dilip S Gaonkar as their independent and dedicated nominees to decide recovery cases of their society.

And whereas, Asstt. Registrar of Cooperative societies South Zone Margao Vide letters referred at Sr.4 above has forwarded the request of Suvarnalaxmi Sahakari Patapeddhi Maryadit, Margao to designate Adv. Dilip S Gaonkar as Registrars nominees to adjudicate dispute referred to them by Society.

Therefore, in exercise of the powers conferred under section 123(B) of the Goa Coop. Societies Act, 2001 read with Rule 116 of the Goa Cooperative Societies Rules ,2003, I, the undersigned hereby authorize Adv. Dilip S Gaonkar to entertain all the dispute referred to them in matters of recovery of outstanding loan by Suvarnalaxmi Sahakari Patapeddhi Maryadit, Margao without routing through the Department.

When a purported dispute is referred by the society, the above named nominees are authorised to first decide under sub-section (1) of section 86 of the Goa Cooperative Societies Act 2001 whether the matter referred by society involves a dispute and pass appropriate Orders under sub section (1) of section 86 of the Act.

Only upon the nominee satisfying that there exist disputes he shall proceed to adjudicate the same and give award accordingly. The nominee shall abide by the terms and condition on which he was originally appointed as Registrar's nominee vide order read at Sr. No. 1 above.

This appointment shall come into force with immediate effect and shall remain in enforce for one year and same can be withdrawn at any time without assigning any reasons.
