ORDER

Whereas, vide Order at ref. no. 1 above issued by the Registrar of Cooperative Societies u/s. 86 (1) of the Goa Cooperative Societies Act, 2001 read with Rule 116 (1) of the Goa Cooperative Societies Rules, 2003 Adv.Manguirish Kenkre having office at FO-3, 1st Floor Gurukrupa Bldg. Opp. Sai Color Lab ,FI Gomes Road Vasco-Da-Gama was appointed as the Registrars Nominee for deciding the disputes arising in any of the Cooperative Societies referred to him by the Registrar of Cooperative Societies /Asst. Registrars of Cooperative Societies.

And whereas, vide letter at ref. no. 3 above, the Janavikas Urban Coop. Credit Society Ltd., Zuari Nagar Sancoale- Goa (Reg. No. -8- RES-(a) -61/ South Goa -92) submitted request for appointment of Adv. Manguirish Kenkre as dedicated Registrar's Nominee for their Society. The Registrar of Co-op. Societies in exercise of the powers conferred u/s. 123(B) of the Goa Cooperative Societies Act, 2001 read with Notification at ref. no. 2 above appointed Adv.Manguirish Kenkre as the dedicated Registrar's Nominee, thereby authorizing him to entertain and decide all the disputes submitted to him by the said Society, without referring to this office. The initial period of authorization was for 1 year from 29/09/2020 to 28 /09/2021.

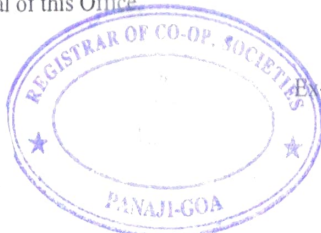
And whereas, the Cooperative officer (Unit Incharge) O/ o Asst. Registrar of Coop. Societies, South Zone Margao vide letter referred at ref. no.5 above has submitted the proposal of the Janavikas Urban Coop. Credit Society Ltd., Zuari Nagar Sancoale- Goa for extension of said authorization for a further period.

Now therefore, in exercise of the powers conferred under Section 123B of the Goa Cooperative Societies Act, 2001, I, the Registrar of Cooperative Societies hereby extend the authorization of Adv. Manguirish Kenkre as dedicated Registrar's Nominee for Janavikas Urban Coop. Credit Society Ltd., Zuari Nagar Sancoale- Goa for a further period of 2 years with retrospective effect from 29 /09 /2021 to 28 /09 /2023.

All other terms and conditions mentioned in the Orders referred at ref. nos. 1 & 4 above shall continue to remain in force.

The Registrar reserves the right to withdraw this Order at any stage without assigning any reason thereof.
