**O R D E R**

Whereas vide Order at reference No. 3 above issued by the Registrar of Cooperative Societies in exercise of the powers conferred upon him by Notification at reference No. 1 above issued by the Government by exercising the powers under Section 126A of the Goa Cooperative Societies Act, 2001 (Goa Act No. 36 of 2001), the General Manager of the Sankhali Urban Cooperative Credit Society Ltd., Sankhali Goa was authorized to act as RECOVERY OFFICER/SALE OFFICER in relation to recovery of debts and to attach and sell the property of defaulters or to execute any decree by attachment and sale of property and execution of all recovery orders of decree holder viz The Sankhali Urban Cooperative Credit Society Ltd., Sankhali Goa passed by the Asstt. Registrar of Cooperative Societies, ABN/EXE or the Nominee of Registrar, as provided under Section 91D of the said Act.

And whereas, said appointment was initially for a period till 31/03/2021 and same was further extended for one year ending on 30/3/2022 vide Order at reference No. 4 above.

And whereas vide letter dated 26/04/2022 at reference No. 5 above, Chairman of the Sankhali Urban Cooperative Credit Society Ltd., has requested for extending said authorization for further period of one year.

Now, therefore in exercise of the powers conferred upon undersigned under Section 123B read with Notification dated 10/02/2020 at reference No. 1 above, the appointment and authorization of said RECOVERY OFFICER/SALE OFFICER is hereby further extended for a period of one year with retrospective effect from 01/04/2022 to 31/03/2023.

All the terms and conditions mentioned in the Order referred to at Sr. No. 4 above shall continue to apply.

The undersigned reserves the right to withdraw this Order at any stage without assigning any reasons.
