**ORDER**

Whereas, vide Order dated 21/04/2017 read at no.1 above issued by the Registrar of Cooperative Societies under section 86 (1) of the Goa Cooperative Societies Act, 2001 read with Rule 116 (1) of the Goa Cooperative Societies Rules, 2003, a panel of Registrar's Nominee was constituted by appointing the Advocates as Registrar's Nominee for deciding the disputes arising in any of the Cooperative Societies referred to them by the Registrar of Cooperative Societies /Asstt. Registrars of Cooperative Societies.

And whereas, Adv. Sagar R. Parab is one of the appointed Registrar's Nominee and his name is reflecting in the above read order at serial no. 22.

And whereas, vide letter read at no. 3 above, the Secretary of the Society M/s. The Bharat Urban Cooperative Credit Society Ltd., Shop No. 87, Mezzanine Floor, New Market Complex, Upper Bazar, Ponda, Goa (Reg. No. ARCS/PZ/Credit/1/Goa dated 14/12/2012) { hereafter referred to as the "Society" or "said Society"} has submitted a request to Asstt. Registrar of Cooperative Societies, Ponda Zone requesting for authorizing Adv. Sagar R. Parab as their independent and dedicated nominee to decide recovery cases of their Society, without routing through the Office of RCS or ARCS.

And whereas, the Asstt. Registrar of Coop. Societies, Ponda Zone, Ponda, Goa vide letter read at no. 4 above forwarded the request of the said Society to the Registrar requesting to authorise Adv. Sagar R. Parab as dedicated Registrar's Nominee to adjudicate dispute referred to him by said Society directly without routing through the Registrar or Assistant Registrar.

Therefore, the Registrar of Cooperative Societies in exercise of the powers conferred u/s. 123(B) of the Goa Co-operative Societies Act, 2001 read with Circular

dated 06/03/2020 read at no. 2 above hereby appoint Adv. Sagar R. Parab, having office at 3<sup>rd</sup> floor, Shetye Sankul, Tisk, Ponda, Goa as the dedicated Registrar's Nominee, thereby authorizing him to entertain and decide all the disputes submitted to him by the said society, without referring to this office.

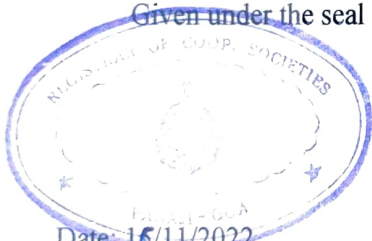
Further, the above named nominee is authorised to decide under sub-section (1) of section 86 of the Goa Cooperatives Societies Act, 2001 whether the matter referred to him by Society involves a dispute and pass appropriate Order under sub section (1) of section 86 of the Act. On being satisfied that there exists a dispute, the authorized dedicated nominee shall proceed to adjudicate the same and pass Award accordingly.

The authorized dedicated nominee shall abide by the terms and condition on which he was originally appointed as Registrar's nominee vide order read at no. 1 above.

This appointment shall come into force with immediate effect and shall remain in force for one year.

The undersigned reserves the right to withdraw this authorization at any time without assigning any reason.
