**ORDER**

Whereas vide Order dated 21/04/2017 read at no.1 above issued by the Registrar of Cooperative Societies under section 86 (1) of the Goa Cooperative Societies Act, 2001 read with Rule 116 (1) of the Goa Cooperative Societies Rules, 2003, a panel of Registrar's Nominee was constituted by appointing the Advocates as Registrar's Nominees for deciding the disputes arising in any of the Cooperative Societies referred to them by the Registrar of Cooperative Societies /Assistant Registrars of Cooperative Societies.

And whereas, Adv. Ramdas K. G. Temyekar, C/1/2, 3<sup>rd</sup> Floor, Fonseca Arcade, Opposite Mamlatdar Building, Tisk, Ponda, Goa is one of the appointed Registrar's Nominees and his name is reflecting in the above referred Order at sr. no. 29.

And whereas, vide letter read at no. 3 above, the Manager of M/s. Shree Vitthal Rakhumai Urban Cooperative Credit Society Ltd., Upper Bazar, Ponda, Goa has submitted an application enclosing resolution no. 08 dated 27/07/2022 adopted by Board of Directors of society requesting the Asstt. Registrar of Cooperative Societies, Ponda Zone for authorizing Adv. Ramdas K. G. Temyekar as their independent and dedicated nominee to decide recovery cases of their Society.

And whereas, the Asstt. Registrar of Coop. Societies, Ponda Zone, Ponda, Goa vide letter read at sr. no. 4 above have forwarded said request of Shree Vitthal Rakhumai Urban Cooperative Credit Society Ltd., Upper Bazar, Ponda, Goa to the Registrar requesting to authorise Adv. Ramdas K. G. Temyekar, C/1/2, 3<sup>rd</sup> Floor, Fonseca Arcade, Opposite Mamlatdar Building, Tisk, Ponda, Goa as Registrar's Nominee to adjudicate dispute referred to him directly by Society without routing through the Office of Registrar or Assistant Registrar.

Therefore, I, the undersigned Registrar of Cooperative Societies in exercise of the powers conferred u/s. 123(B) of the Goa Co-operative Societies Act, 2001 (Goa

Act No. 36 of 2001) read with Circular dated 06/03/2020 at ref. no. 2 above hereby appoint Adv. Ramdas K. G. Temyekar, CT/2, 3<sup>rd</sup> Floor, Fonseca Arcade, Opposite Mamlatdar Building, Tisk, Ponda, Goa as the dedicated Registrar's Nominee, thereby authorizing him to entertain and decide all the disputes submitted to him directly by the said Society, without routing through the Office of Registrar or Assistant Registrar.

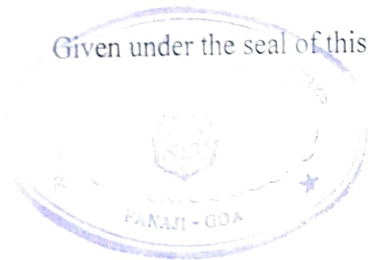
Further, the above named dedicated Nominee is authorised to decide under sub-section (1) of section 86 of the Goa Cooperatives Societies Act, 2001 whether the matter referred to him by Society involves a dispute and pass appropriate Order under sub section (1) of section 86 of the Act.

On being satisfied that there exists a dispute, the Authorized Nominee shall proceed further to adjudicate the same and pass Award accordingly. The Authorized Nominee shall abide by the terms and conditions on which he was originally appointed as Registrar's Nominee vide Order read at no. 1 above.

This appointment shall come into force with immediate effect and shall remain in force for a period of one year.


