**ORDER**

Whereas, Adv. Sushma T. Mandrekar alias Sushma Harish Chodankar, having office at H. No. 713/33, Ardhawada Mayem, Bicholim-Goa was appointed as Registrar's Nominee under Section 86(1) of the Goa Cooperative Societies Act, 2001 read with Rule 116 (1) of The Goa Cooperative Societies Rules, 2003 vide Order read at Sr. No. 2 above and her name is reflecting at Sr. No. 21 in the said Order.

And whereas, the Asstt. Registrar of Coop. Societies, Bicholim Zone, Sankhali vide letter at Sr. No. 3 above, has forwarded the request of The Bicholim Mahila Urban Cooperative Credit Society Ltd., Bicholim-Goa to designate Adv. Sushma T. Mandrekar alias Sushma Harish Chodankar as its dedicated nominee to adjudicate dispute referred by society.

In view of above, the above named nominee Adv. Sushma T. Mandrekar alias Sushma Harish Chodankar in exercise of powers conferred under Section 123(B) of the Goa Coop. Societies Act, 2001 I, the undersigned hereby authorize the above named nominee to entertain the disputes referred to her on recovery of loan overdue matter by The Bicholim Mahila Urban Cooperative Credit Society Ltd., Bicholim-Goa.

When a purported dispute is referred by the society, the above named nominee is authorised to first decide under sub-section (1) of Section 86 of the Goa Cooperative Societies Act whether the matter referred by society involves a dispute and pass appropriate Orders under sub section (1) of Section 86.

Only upon the nominee satisfying that there exists a dispute she shall proceed to adjudicate the same and give award accordingly. The nominee shall abide by the terms and condition on which he was originally appointed as nominee read at Sr. No. 2 above.

This appointment shall come into force with immediate effect and shall remain in force for one year and same can be withdrawn at any stage without assigning any reason.
