ORDER


In view of above, the above named nominee **Adv. Sushma T. Mandrekar alias Sushma Harish Chodankar,** in exercise of powers conferred under Section 123(B) of the Goa Coop. Societies Act, 2001 read with Rule 116 of the Goa Cooperative Societies Rules, 2003 I, the undersigned hereby authorise the above named nominee to entertain all disputes referred to him by The Bordem Urban Coop. Credit Society Ltd., Bordem, Bicholim-Goa without routing it through this department.

When a purported dispute is referred by the society, the above named nominee is authorised to first decide under sub-section (1) of section 86 of the Goa Cooperative Societies Act whether the matter referred by society involves a dispute and pass appropriate Orders under sub section (1) of section 86.

Only upon the nominee satisfying that there exists a dispute she shall proceed to adjudicate the same and give award accordingly. The nominee shall abide by the terms and condition on which he was originally appointed as nominee read at Sr. 1 above

This appointment shall come into force with immediate effect and shall remain in force for one year and same can be withdrawn at any stage without assigning any reason.
