ORDER

Whereas, vide Order read at Sr. No. 3 above, late Adv. Satyawan Gunlo Palkar, Ponda-Goa was appointed as the Registrar's Nominee from the panel constituted vide Order read at Sr. No. 1 above to adjudicate the disputes referred to him by **The Savoi - Verem V.K.S.S. Society Ltd., Savoi - Verem Ponda-Goa.**

And Whereas, the Society vide its letter read at Sr. 5 above has informed that the society in its board meeting held on 26-10-2020 has resolved to appoint **Adv. Bhavesh R. Parab, Ponda-Goa** in place of late Adv. Satyawan Gunlo Palkar.

Therefore, in view of above, in partial modification to the office order read at Sr. No. 3 above Adv. Bhavesh R. Parab, Ponda-Goa in exercise of powers conferred under section 123B of the Goa Cooperative Societies Act, 2001 is hereby authorised by the undersigned in place of Late Adv. Satyawan Gunlo Palkar to entertain all the disputes referred to him in the matter or recovery of loan overdues by the Savoi Verem V.K.S.S. Society Ltd., Savoi-Verem Ponda-Goa.

When a purported dispute is referred by the society, the above named nominee is authorised to first decide under section (1) of section 86 of the Goa Cooperative Societies Act, 2001 whether the matter referred by the society involves a dispute and pass appropriate orders under section (1) of section 86 of the Act.

Only upon the nominee satisfying that there exists a dispute he shall proceed to adjudicate the same and give award accordingly. The nominee shall abide by the terms and condition on which he was originally appointed as nominee vide order to be read as Sr. No. 1 above.

This appointment shall come into force with immediate effect and shall valid for one year unless renewed and in subject to withdrawal/being revoked at any stage without assigning any reasons.
