Now, therefore, I the undersigned Registrar of Cooperative Societies in exercise of the powers vested in me under section 123 (B) of the said Act, hereby delegate the powers vested in me under section 91 D of the said Act, read with Rule 124 of the Goa Cooperative Societies Rules, 2003 to Shri Nitin V. Chopdekar, Junior officer of the Goa Urban Cooperative Bank Ltd., Panaji to act as Recovery Officer/Sale Officer in relation to the recovery of debts and to attach and sell the property and to execute all recovery orders of decree holder passed by the Arbitrator/ Assistant Registrar of Co-operative Societies HQ- III, Camp Court, Panaji, Goa or the Nominee of Registrar in respect of the said Bank.

The delegation of powers to Shri Nitin V. Chopdekar, Junior officer appointed as sales & Recovery Officer by this Order shall be effective from the date of his taking over charge from Shri Damodar B. Puranik on account of his transfer. This delegation of powers shall be valid till 05/09/2022.

The conditions laid down under Notification dated 04/07/2020 referred at no. 1 above as were applicable to Shri Damodar Puranik shall continue to remain in force and be applicable to the Shri Nitin V. Chopdekar, Junior Officer appointed as Sales Officer/ Recovery Officer by this Order.
