### NOTIFICATION

Whereas vide Notification read at no. 1 above issued by the Government exercising the powers under Section 126A of the Goa Cooperative Societies Act, 2001 (Goa Act 36 of 2001) {hereafter referred to as 'Act'}, the provision of Sub-section (1) of section 91 D of the Act was modified and the Registrar of Cooperative Societies was authorized to appoint Officers of Cooperative Credit Societies, V. K. S. S. Societies having credit counters and Multipurpose Societies as **RECOVERY OFFICER / SALE OFFICER** upon receipt of individual proposals subject to the terms and conditions as may be incorporated in the Order.

And whereas vide Notification read at no. 2 above issued by the Registrar of Cooperative Societies, the 3 Officers namely Shri Sanmit M. Bodke; Shri Heramb S. Prabhudesai; and Shri Damodar B. Puranik of the **Goa Urban Cooperative Bank Ltd., Dr. A. Borker Road, Panaji, Goa** were delegated with the powers to recover certain sums by attachment and sale of property vested in Registrar of Cooperative Societies under Section 91D of the Goa Cooperative Societies Act, 2001 read with Rule 124 of the Goa Cooperative Societies Rules, 2003 subject to the following conditions:-

1. The Officer appointed shall follow all the procedures as laid down under the Goa cooperative Societies Act, 2001 and the Goa Cooperative Societies Rules, 2003 or in compliance with any other relevant provisions of any other Act/Rules and also Byelaws of the Bank concerned while executing a Decree;
2. The Board of Directors of the Bank shall be fully responsible along with the Chief Executive Officer/Managing Director and above Officers for any acts in contravention of the Act, Rules and Bye-laws;

**File.** The Board of Directors shall review the performance of the above Officers every month and ensure compliance.

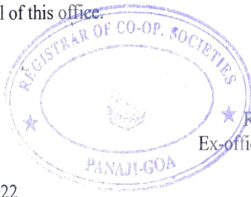
The delegation of powers was for a period from 04/09/2020 to 03/09/2021, which was further extended for a period from 04/09/2021 to 05/09/2022 vide Order read at no. 3 above. Thereafter, vide another Order dated 02/12/2022, the delegation of powers was modified replacing another Officer Shri Nitin V. Chopdekar in place of Shri Damodar B. Puranik for retrospective period from 22/08/2022 to 05/09/2022.

And whereas vide letters read at nos. 4 and 6 above, the Goa Urban Cooperative Bank Ltd., Panaji, Goa has requested to grant further extension to the Officers of their Bank to act as Sale -Cum-Recovery Officer for their Bank.

Now, therefore in exercise of the powers conferred upon undersigned Registrar of Cooperative Societies under Section 123B of the Goa Cooperative Societies Act, 2001 read with the Notification read at no. 1 above, the delegation of powers to **Shri Nitin V. Chopdekar, Officer of the Goa Urban Cooperative Bank Ltd., Dr. A. Borker Road, Panaji, Goa** is hereby further extended for a further period of one year with retrospective effect from **06/09/2022 to 05/09/2023**.

All the terms and conditions mentioned in the Notification read at no. 2 above shall continue to apply. The undersigned reserves the right to withdraw this Order at any stage without assigning any reasons.
