A copy of above referred letter along with Annexures is enclosed herewith.

All Unit in- charges (ARCS or CO) at Zonal level are hereby directed to inform whether any Primary Agricultural Credit Societies (PACS)/ Vividh Karyakari Sahakari Saunstha (VKSS) under their control are willing to take up the pilot project under the said Central Scheme. Under this scheme the estimated cost of project for construction of Grain storage facility/warehouse, etc. is Rs. 2.11 Crores, out of which Rs. 51 lakhs is the subsidy component and Rs. 1.60 Crores is the Loan to be repaid by the PACS.


The eligible criteria for PACS for availing said Scheme is as under.

- i. Willingness of PACS;
- ii. Eligibility of Goa State Cooperative Bank Ltd. to avail re-finance from NABARD from special refinance facility – transformation of PACS into MSCs;

- iii. Availability of one to two acre land owned by PACS;
- iv. Feasibility of proposed project;
- v. Sufficient borrowing power with the PACS.

All Unit Incharges (ARCS or CO) are directed to verify whether any PACS/VKSS Society under their charge is willing to take up this project and furnish information about the PACS/VKSS who are willing to take the scheme and are found eligible under the scheme.

The above information should reach Head Office on or before 06/06/2023.
